Part 1: General Privacy and Data Protection

1. Introduction

SGS Academy Trust is committed to conducting its business in accordance with all applicable Data Protection laws and regulations and in line with the highest standards of ethical conduct.

The Trust's leadership and management team is fully committed to ensuring continued and effective implementation of this policy and expects all employees and Third Parties to share in this commitment. Any breach of this policy will be taken seriously and may result in disciplinary action or business sanction.

2. Definitions

3. Application

This policy applies to all Processing of Personal Data in electronic form (including electronic mail and documents created with computer software) or where it is held in manual files that are structured in a way that allows ready access to information about individuals. This policy has been designed to establish a baseline standard for the Processing and protection of Personal Data by SGS Academy Trust staff.

This policy does not form part of the formal staff contract of employment, but it is a **condition of employment** that staff abide by the rules and policies made by the Academy Trust from time to time. Any breach of this policy could, therefore, result in disciplinary proceedings. Any member of staff who considers that this Policy has not been followed, should raise the matter immediately with their line manager.

4. Principles

When Processing Personal Data, SGS Academy Trust staff will adhere to the following principles at all times:

Principle 1: **Lawfulness, Fairness and Transparency**

Personal Data shall be processed lawfully, fairly and in a transparent manner in relation to the Data Subject. This means, SGSAT will tell the Data Subject what Processing will occur (transparency), that the Processing will match the description given to the Data Subject (fairness), and that processing will be for one of the purposes specified in the applicable Data Protection regulation (lawfulness).

Principle 2: **Purpose Limitation**

SGSAT shall only collect Personal Data for specified, explicit and legitimate reasons and will not further process data in a manner that is incompatible with those reasons. This means SGSAT will aim to specify exactly what the Personal Data collected will be used for and limit the Processing of that Personal Data to only what is necessary to meet the specified purpose.

Principle 3: **Data Minimisation**

SGSAT will endeavour to ensure that Personal Data is adequate, relevant and limited to what is necessary in relation to the purpose and reasons for which it is processed. This means SGSAT will not store any Personal Data beyond what is strictly required.

Principle 4: **Accuracy**

Personal Data, held by SGSAT, shall be accurate and, kept up to date. This means SGSAT will maintain processes for identifying and addressing out-of-date, incorrect and redundant Personal Data.

Principle 5: **Storage Limitation**

SGSAT shall keep Personal Data in a form which permits identification of Data Subjects for no longer than is necessary for the purposes for which the Personal Data is/was Processed. This means SGSAT will, wherever possible, store Personal Data in a way that limits or prevents identification of the Data Subject.

Principle 6: **Integrity & Confidentiality**

SGSAT shall only process Personal Data in a manner that ensures appropriate security of that data, including protection against unauthorised or unlawful Processing, and against accidental loss, destruction or damage. SGSAT will use appropriate technical and organisational measures to ensure the integrity and confidentiality of Personal Data is maintained at all times.

Principle 7: **Transferral**

SGSAT will only transfer Personal Data to third parties, under contract, when necessary to provide services to our staff and customers or when required to do so by law. SGSAT will never sell personal data or allow Personal Data to be transferred to a country outside the European Economic Area, unless that country has equivalent levels of protection for personal data.

Principle 8: **Accountability**

The Data Controller shall be responsible for and be able to demonstrate compliance.

5. The Collection of Personal Data

SGS Academy Trust will only collect Personal Data about a Data Subject if our Mission and the nature of our business purpose necessitates its collection; or if collection is necessary in emergency circumstances in order to protect the vital interests of the Data Subject or to prevent serious loss or injury to another person.

Personal Data will only be collected from the Data Subject or other public bodies. If Personal Data is collected from someone other than the Data Subject or another Public Body, SGSAT will inform the Data Subject. Except where the personal data, collected from someone other than the Data Subject, is collected 'en masse', with a sound legal basis and the effort needed to inform all Data Subjects is disproportionate. Decisions relating to proportionality must be reviewed by the Data Protection Officer.

Data Subject Consent

SGS Academy Trust will only obtain Personal Data by lawful and fair means and, where appropriate with the knowledge and Consent of the individual concerned. Where a need exists to request and receive the Consent of an individual prior to the collection, use or disclosure of their Personal Data, SGSAT is committed to seeking such Consent.

Where consent is required SGS Academy Trust commits to:

- **Making appropriate disclosures** to the Data Subject in order to obtain valid Consent;
- **Ensuring the request for consent is presented in a manner which is intelligible** and in an easily accessible form, using clear and plain language;
- **Ensuring the Consent is freely given** (that is: not based on a contract that is conditional to the Processing of Personal Data that is unnecessary for the performance of that contract); and,
- **Providing a simple method for a Data Subject to withdraw their Consent at any time.**

In all instances where Consent is sought, it will be: Documented by date, method and content of the disclosures made, as well as the validity, scope, and volition of the Consents given; and the Schedule 2 Checklist will be completed.

Where it is not possible to fully identify the purpose of personal data processing, for example where that processing is for academic or scientific research purposes, data subjects shall be allowed to give their consent to processing 'in keeping with recognised ethical standards for research'; however such consent is limited only to areas of research or types of processing allowed by the intended purpose.

Where consent is required for data collection or processing, SGSAT will require parental consent for anyone under the age of 16; and, the Designated Data controller in each School will take all reasonable measures to verify the validity of that consent by ensuring that it is given only by a parent or legal guardian.

Where a School's Designated Data controller has reason to believe that a child, under the age of 16, may object to their parent providing consent on their behalf; this must be referred to the appropriate Designated Safeguarding Lead and the Data Protection Officer for review.

6. Notification of Data Held and Processed

All staff, pupils and other users of the Academy Trust are entitled to:

- Know what information the Academy Trust holds and processes about them and why;
- Know how to gain access to it;
- Know how to keep it up-to-date; and,
- Know what the Academy Trust is doing to comply with its obligations under Data Protection legislation.

7. Data Use (General Processing)

SGSAT uses the Personal Data it collects for the following broad purposes:

1. The general running and business administration of the Trust;
2. To provide services and support to SGSAT customers, and monitor the ongoing administration and management of customer services;
3. To advertise, promote, inform and market to stakeholders, prospective customers and the general public the services offered through SGS Academy Trust and SGS Group;
4. To monitor a range of activities including performance, achievements and health and safety; and,
5. To ensure compliance with legal obligations to regulatory, awarding and funding bodies and to Her Majesty's Government.

SGS Academy Trust will always consider the use of a Data Subject's personal information from their perspective and whether its use is within their expectations or if they are likely to object.

In other words, if we believe an individual might object to our processing of their personal data, we will not undertake any such processing without legal justification or express consent.

In any circumstance where Consent has not been gained for specific processing SGSAT will address the following additional conditions to determine the fairness and transparency of that processing, beyond the original purpose for which the Personal Data was collected:

- Any link between the purpose for which the Personal Data was collected and the reasons for intended further Processing;
- The context in which the Personal Data was collected, in particular regarding the relationship between Data Subject and the Data Controller;
- The nature of the Personal Data, in particular whether Special Categories of data are being processed, or whether Personal Data related to criminal convictions and offences are being processed;
- The possible consequences of the intended further Processing for the Data Subject; and,
- The existence of appropriate safeguards pertaining to further Processing, which may include Encryption, Anonymisation or Pseudonymisation.

8. Data use (Necessary Processing)

SGSAT will only Process Personal Data where that processing is a necessary, targeted and proportionate way of achieving the Academy Trust's Mission.

By way of general guidance:

- The Trust's lawful basis for processing Personal Data in respect of employee information is that the processing is necessary to fulfil contractual and HMRC obligations and those within the Keeping children safe in education statutory guidance.
- The Trust's lawful basis for processing Personal Data in respect of enrolment, funding, awarding body registration, teaching, learner support, performance monitoring and research is that the processing is necessary for each school within the Trust to perform a task in the public interest and for its official functions; these tasks and functions have a clear basis in law.
- The Trust's lawful basis for processing Personal Data in respect of alumni relations, internal events, fundraising purposes, direct marketing and marketing research is the pursuit of the Academy Trust's legitimate interests. (This includes the intra-SGS Group transfer of data for administrative purposes, where those purposes are not detrimental to the rights of the Data Subject)
- SGS Academy Trust has a lawful basis for further processing, where that processing assists the Academy Trust in achieving its Mission and is compatible with the purpose for which the data was initially collected.
- SGS Academy Trust will further process Personal Data for archiving purposes in the public interest and for research and statistical purposes.

- The Processing of Personal Data in respect of keeping children safe in education is a legal obligation under the Education Act 2002.
- The Academy Trust will share data with the Department for Education (DfE) on a statutory basis. This data sharing underpins educational funding and educational attainment policy and monitoring.
- Where required, SGS Academy Trust will share information about pupils with our local authority (LA) and the Department for Education (DfE) under section 3 of the Education (Information about Individuals) (England) Regulations 2013.
- For academies and free schools, and where required, SGS Academy Trust will share information about pupils with the (DfE) under Regulation 5 of the Education (Information about Individuals) (England) Regulations 2013.
- The Academy Trust will share information about pupils, including special category data, with the Fisher Family Trust or Alps. This information is shared for the purpose of educational attainment monitoring. Information shared with the Fisher Family Trust is subject to a data-sharing agreement for schools using Aspire and is covered through the end user license agreement, which is aligned to the GDPR.
- When undertaking any major project, concerning the Processing of Personal Data, or considering processing that is likely to result in a high risk to individuals' interests. SGSAT will undertake a Data Protection Impact Assessment (DPIA); and the Schedule 5 checklist will be used to determine if a DPIA is required.

9. Special Categories of Data

SGSAT may process Special Categories of data (also known as sensitive data) where such processing is necessary for compliance with a legal obligation to which the SGSAT is subject; or, where processing is necessary for the performance of a task carried out in the public interest; or in the exercise of official authority vested in the controller. Processing of special category data may also be carried out where it is necessary for the purposes of the legitimate interests pursued by the SGSAT or by a third party **and** that processing is necessary for reasons of substantial public interest.

Example conditions of substantial public interest:

Schedule 1 of the Data Protection Act 2018, paragraph 8: processing for the purposes of identifying or keeping under review the existence or absence of equality of opportunity or treatment between groups of people specified in relation to that category with a view to enabling such equality to be promoted or maintained; and,

Schedule 1 of the Data Protection Act 2018, paragraph 18: Safeguarding of children and individuals at risk.

Otherwise, SGSAT will only process Special Categories of data (also known as sensitive data) where the Data Subject has expressly consented to such Processing or where one of the following conditions apply:

1. The Processing relates to Personal Data which has already been made public by the Data Subject;
2. The Processing is necessary for the establishment, exercise or defence of legal claims;
3. The Processing is specifically authorised or required by law (Including the Public Sector Equality Act (Specific Duties) Regulations);
4. The Processing is necessary to protect the vital interests of the Data Subject or of another person where the Data Subject is physically or legally incapable of giving consent; or
5. Further conditions, including limitations, based upon national law related to the processing of genetic data, biometric data or data concerning health.

10. Marketing

As a general rule SGSAT will not send promotional or direct marketing material to an SGSAT Contact through digital channels such as mobile phones, email and the Internet, without first obtaining their Consent. If consent is sought the Schedule 2 Checklist will be completed.

Any request to carry out a digital marketing campaign or internal event without obtaining prior Consent from the Data Subject must first have it approved by the Data Controller, in consultation with the Data Protection Officer.

Where Personal Data Processing is approved for digital marketing purposes, the Data Subject **will be informed at the point of first contact that they have the right to object, at any stage, to having their data Processed for such purposes.** If the Data Subject puts forward an objection, digital marketing related Processing of their Personal Data will cease immediately and their details will be kept on a suppression list with a record of their opt-out decision, rather than being completely deleted.

It should be noted that where digital marketing is carried out in a 'business to business' context, there is no legal requirement to obtain an indication of Consent to carry out digital marketing to individuals provided that they are given the opportunity to opt-out.

11. Responsibilities of Staff

In respect of Personal Data, SGSAT Staff (including prospective and former staff) should:

1. Check that any information which they provide to the Trust, in connection with their employment, is accurate and up-to-date;
2. Compile, maintain and review the Information Asset Register annually
3. Inform the Trust of any changes to the information which they have provided e.g. changes of address;
4. Check the information which the Trust may send out from time-to-time, giving details of information kept and processed about staff;
5. Informing the Academy Trust of any errors or changes. **Neither the Academy Trust nor SGS Group can be held responsible for any errors unless the staff member has informed the Academy Trust of them.**

In respect of Data Processing

6. Ensure that Personal Data is anonymised or Pseudonymised prior to processing;
7. Prevent unauthorised persons from gaining access to data processing systems in which Personal Data is processed;
8. Prevent persons entitled to use a data processing system from accessing Personal Data beyond their needs and authorisations;
9. Ensure that Personal Data in the course of electronic transmission (or during transport) cannot be read, copied, modified or removed without authorisation;
10. Ensure that personal data is not transferred outside of the Academy Trust, in any form, which can be read, copied, modified or removed without authorisation;
11. Ensure that access logs are maintained to establish whether, and by whom the Personal Data was entered into, modified on or removed from a data processing system;
12. Ensure that in the case where Processing is carried out by a Data Processor, the data can be processed only in accordance with the instructions of the Data Controller (SGS);
13. Ensure that Personal Data is protected against undesired destruction or loss;
14. Ensure that Personal Data collected for different purposes can and is only processed separately;
15. Ensure that Personal Data is not kept for longer than necessary.

If and when, as part of their responsibilities, staff collect or release information about other people, (e.g. about pupils' course work, opinions about ability, references to other academic institutions, or details of personal circumstances), they must comply with the Principals of the Data Protection Act; and staff should familiarise themselves with Schedule 1: Guidelines for Staff

This will include:

- Seeking informed consent from the Data Subject; and,

- Undertaking such checks as necessary to verify a person's identify before releasing Personal Information.

12. Pupil Obligations

Pupils (and their Parents/Guardians) must ensure that all personal data provided to the Academy Trust is accurate and up-to-date. **The Trust cannot be held responsible for any errors unless pupils or their parents/guardians, have informed the Trust of them.**

Teachers should be conscious of obligations under the Data Protection Act if Personal Data is being collected and processed using the Academy Trust's computer services and advise them accordingly.

Pupils who use the Academy Trust's computer facilities may, from time-to-time, process personal data. If they do so they must notify the Data Controller. All pupils must comply with the Trust's IT: Acceptable Use Policy.

13. Profiling & Automated Decision-Making

SGSAT will only engage in profiling and automated decision-making where it is necessary to enter into, or to perform, a contract with the Data Subject or where it is authorised by contract (For example: during on-line enrolment or to affect the timely collection of debt).

Where SGSAT uses profiling and automated decision-making, this will be disclosed to the relevant Data Subjects; and in such cases the Data Subject will be given the opportunity to:

- Express their point of view;
- Obtain an explanation for the automated decision;
- Review the logic used by the automated system;
- Supplement the automated system with additional data;
- Have a human carry out a review of the automated decision;
- Contest the automated decision; or
- Object to the automated decision-making being carried out.

Before engaging in any profiling and automated decision making, SGSAT will ensure that the data used is accurate and confirm compliance with section 13 with the Academy Trust's Data Protection Officer.

14. Data Security

All staff are responsible for ensuring that:

- **Any personal data which they hold is kept securely;**
- **Personal information is not disclosed either orally or in writing or accidentally or otherwise to any unauthorised third party.**

Staff should note that unauthorised disclosure will usually be a disciplinary matter and, in some cases, may be considered to be gross misconduct.

Personal information should be:

- If it is computerised, stored in an appropriate secure location such as your "My Documents" or an appropriate file share, Academy or School system;
- Securely locked away i.e. in a locked filing cabinet or drawer;
- Removable media and portable devices MUST be encrypted and protected by a suitable password;
- NEVER sent by email unless it has been encrypted.

15. Data Subject Rights

SGSAT has an established system to enable and facilitate the exercise of Data Subject rights related to:

- Pupils (and their parents/guardians) have the right to be informed as to how their personal data is processed. This information is contained within the SGS Academy Trust Privacy Notice
- Information access (pupils (and their parents/guardians) have the right to access their educational record (as defined by the Education (Information) (England) Regulations 2005)
- Objection to Processing
- Objection to automated decision-making and profiling
- Restriction of Processing
- Data portability
- Data rectification
- Data erasure

If an individual makes a request relating to any of the rights listed above, SGSAT will consider each such request in accordance with all applicable Data Protection laws and regulations. No administration fee will be charged for considering and/or complying with such a request unless the request is deemed to be unnecessary or excessive in nature.

Data Subjects are entitled to obtain, based upon a request made to the Academy Trust and upon successful verification of their identity, the following information about their own Personal Data:

- The purposes of the collection, Processing, use and storage of their Personal Data;
- The source(s) of the Personal Data, if it was not obtained from the Data Subject;
- The categories of Personal Data stored for the Data Subject;
- The recipients or categories of recipients to whom the Personal Data has been or may be transmitted, along with the location of those recipients;
- The envisaged period of storage for the Personal Data or the rationale for determining the storage period; and,
- The use of any automated decision-making.

It should be noted that situations may arise where providing the information requested by a Data Subject would disclose Personal Data about another individual. In such cases, information must be redacted or withheld as may be necessary or appropriate to protect that person's rights.

Staff, pupils and other users of the Academy Trust wishing exercise a Data Subject Right, regarding any personal data that is being kept about them, either on computer or in certain files, are advised to complete the Academy Trust 'Data Subject Request Form' at Schedule 5 and email it to DataPrivacy@sgscol.ac.uk

16. Complaints Handling

Data Subjects with a complaint about the Processing of their Personal Data, should put forward the matter in writing to the Data Protection Officer. An investigation of any complaint will be carried out to the extent that is appropriate based on the merits of the specific case. The Data Protection Officer will inform the Data Subject of the progress and the outcome of the complaint within a reasonable period.

If the issue cannot be resolved through consultation between the Data Subject and the Data Protection Officer, then the Data Subject may, at their option, seek redress through mediation or via a complaint to the Information Commissioners Office.

Part 2 Special Provisions

17. Data Requests from the Police

In certain circumstances, it is permitted that Personal Data be shared without the knowledge or Consent of a Data Subject. This is the case where the disclosure of the Personal Data is necessary for any of the following purposes:

- The prevention or detection of crime;
- The apprehension or prosecution of offenders;
- The assessment or collection of a tax or duty; or
- By the order of a court or by any rule of law.

On occasions the Academy Trust receives requests for information on learners from the Police. The following procedure should be followed:

- The investigating Police Officer should send a DPA (Data Protection Act) form to the Academy Trust. This should be titled Declaration Form for Data User and should be signed by the Investigating Officer and a Senior Officer. The form should detail the exact information the Academy Trust is being asked to disclose regarding a learner.
- The Declaration Form for Data User should be sent to the Head Teacher of the relevant school for authorisation. Once signed the relevant information can be released.
- Copies of the Declaration Form for Data User need not be retained by the relevant school, however a record of the request and the date upon which it was met, must be forwarded to the Data Protection Officer without delay.

19. Electronic communications

The Academy Trust is committed to securing trust and security in its use of digital marketing and communications. The following specific rules will be followed when processing personal data in the context of electronic communications; and the Academy Trust will take reasonable care to comply with ePrivacy regulations.

Electronic communications:

- Marketing by electronic means, including marketing calls, texts, emails and faxes;
- The use of cookies or similar technologies that track information about people accessing the Academy Trust's website or other electronic service.
- The Privacy of stakeholders (not employees) using Academy Trust communication networks or services as regards traffic and location data, itemised billing, line identification services (eg caller ID and call return), and directory listings.

SGS Academy Trust will not engage in unsolicited telephone marketing.

SGS Academy Trust will not engage in unsolicited electronic mail marketing to individuals who have not specifically consented to or opted in to receiving electronic mail.

SGS Academy Trust will engage in electronic mail marketing to existing learners and stakeholders (including perspective learners who have contacted the Academy Trust). The Academy Trust will provide recipients with a simple way to opt out both when we first collect their details and in each instance of marketing activity that we send.

Electronic and digital marketing campaigns, where consent cannot be validly obtained must be authorised by the Data Controller, in consultation with the Data Protection Officer and following the completion of a Data Processing Impact Assessment.

SGS Academy Trust will, from time to time, use bought-in marketing lists, in each instance we will endeavour to screen lists against our own 'do-not-call' list of people who have previously objected to or opted out of telephone calls or electronic marketing. SGS Academy Trust will not sell marketing list unless we have the consent of the listed individuals to do so.

SGS Academy Trust uses cookies. Where cookies are used the Academy Trust will tell users of their existence; explain what the cookies are doing and why; and get the person's consent to store a cookie on their device.

Further guidance on electronic communications can be found in the SGSAT Marketing Policy and Procedure [here](#).

Breaches of ePrivacy will be treated in the same ways a personal data breaches according to section 21 of this policy and the related SGSAT Breach Notification Procedure.

20. The Data Controller and the Designated Data Controller/s

The 'Data Controller' determines the purposes for which, and the manner in which, personal data is, or are to be, processed. This may be an individual or an organisation, and the processing may be carried out jointly or in common with other persons. The Trust Board is the Data Controller under the Act and ultimately responsible for the implementation of and on-going compliance with data privacy and protection requirements, processes and procedures.

The Chief Executive Officer of the Academy Trust is the 'senior responsible officer' overseeing data privacy and protection issues within the Trust. Operational authority for data privacy and protection, within each School and Academy, is delegated by the Chief Executive Officer to the Head Teacher of each School or Academy.

Data Protection Officer

The Data Protection Officer (DPO) will support the Data Controller to demonstrate transparency, accountability and compliance with the EU General Data Protection Regulation (GDPR) and the UK Data Protection Act 2018 (UK GDPR). The DPO will operate with independence, is suitably skilled and granted all necessary authority to report to the 'senior responsible officer' who has direct access to the South Gloucestershire and Stroud Multi-academy Trust Board.

The Data Protection Officer works with designated data controllers whose duties include:

- Informing and advising SGSAT and its employees who carry out Processing pursuant to Data Protection regulations, national law or Union based Data Protection provisions;
- Ensuring the alignment of this policy with Data Protection regulations, national law or Union based Data Protection provisions;
- Providing guidance with regards to carrying out Data Protection Impact Assessments (DPIAs);
- Acting as a point of contact for and cooperating with Data Protection Authorities (Information Commissioners Office);

'Designated Data Controllers' as detailed below, deal with day-to-day operational matters connected with data privacy and protection and are charged with ensuring compliance within their areas of responsibility:

- All members of the Senior Leadership Team of each constituent school or academy;
- Deputy Chief Executive Officer, SGS Academy Trust;
- Chief Group Services Officer;
- Clerk to the Trust Board;
- Clerk to the Local Board of each school/academy;
- Head of Human Resources;

- Group Director of IT Services;
- Head of Finance.

Any in-house queries with regard to data privacy and protection should be addressed to the Data Protection Officer or an appropriate designated Data Controller.

21. Breach Reporting

Any individual who suspects that a Personal Data Breach has occurred due to the theft or exposure of Personal Data must immediately notify the Data Protection Officer providing a description of what has occurred.

The Data Protection Officer will investigate all reported incidents to confirm whether or not a Personal Data Breach has occurred. If a Personal Data Breach is confirmed, the Data Protection Officer will, depending upon the criticality and quantity of the Personal Data involved, follow the relevant authorised procedure. For critical Personal Data Breaches, the Data Protection Officer will initiate and chair an emergency response team to coordinate and manage the Personal Data Breach response.

23. Retention of Data

Personal Data will not be retained for and longer than necessary in relation to the purposes for which it was originally collected, or for which it was further processed.

The Academy Trust expects that: records and information should only be retained for legitimate business use and must not be retained for longer than is necessary for its lawful purpose.

The Trust will keep information about pupils, study and achievements indefinitely in order that we may provide academic references as requested. However, the Trust will cease processing information about pupils, study and achievements, except where the data subject consents or for statutory and compliance reasons after 5 years.

In general, the Trust will keep information about staff for seven years after a member of staff leaves the Academy Trust. Some information, however, will be kept for much longer. This will include information necessary in respect of pensions, taxation, potential or current disputes or litigation regarding the

employment and information required for job references. A non-exhaustive list of information and the Academy Trust's proposed retention time is contained with the Academy Trust's Information Asset Register.

Each Head Teacher will review their Information Asset Register annually and monitor the secure disposal of personal data.

Information held for longer than is necessary carries additional risk and cost – SGSAT will endeavour to ensure that Personal Data and Sensitive Personal Data is up-to-date and maintained for accuracy during the entirety of its retention.

25. Disposal of Data

Once the retention period has elapsed, the Academy Trust will ensure that any information is, suitably destroyed by secure means, i.e. by shredding or pulping.

Schedule 1: STAFF GUIDELINES FOR DATA PROTECTION

All staff will process data about pupils on a regular basis, e.g. when marking registers, writing reports or references, as part of a pastoral or academic or supervisory role.

The information with which staff deal on a day-to-day basis will be 'standard' and will cover categories such as:

- General personal details such as name and address;
- Details about class attendance, course work marks and grades and associated comments;
- Notes of personal supervision, including matters about behaviour and discipline.

Staff should **AVOID** processing 'special category data', that is: Personal Data pertaining to or revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, trade-union membership; data concerning health or sex life and sexual orientation; genetic data or biometric data.

Where processing special category data is unavoidable, it must be anonymised

- Staff **MUST** be able to prove the lawfulness for processing (Article 6 GDPR); and,
- Identify a lawful reason for processing it (Article 9 GDPR)

All staff have a duty to make sure that they comply with the Data Protection principles. In particular, staff must ensure that records are:

- only disclosed as allowed for within the Act
- accurate;
- up-to-date;
- fair;
- kept securely and disposed of safely in accordance with the Academy Trust Data Protection & Retention Policy.

Staff Checklist for Recording Data

- Do you really need to record the information?
- Has the pupil been told that the data will be processed?
- Are you authorised to collect/store/process the data?
- If yes, have you checked with the data subject that the data is accurate?
- Are you sure that the data is secure?
- If you do not have the data subject's consent to process, are you satisfied that it is in the best interests of the pupil or the staff member to collect and retain the data?

Staff Checklist for Disclosing Data

There are some recommended ways of dealing with requests for personal data.

- When dealing with enquiries by telephone it is good practice to offer to call back to a telephone number that is registered on Academy Trust systems to ensure some measure of authentication or perhaps send them the information by email or letter to an address previously registered with the Academy Trust
- When dealing with enquiries direct in person, provide identification or verify through photograph held on the Academy Trust system
- Any third party requests for information must be authorised in writing by the subject and their signature must be checked with the Academy Trust records

You should always take care to prevent the inadvertent disclosure of personal data (for example a pupil's attendance at the Academy Trust) to unauthorised parties.

Enquiries from Police and other Agencies should be referred directly to the Head Teacher of the relevant school and should be accompanied by a "Declaration Form for Data User".

If you are not sure, you should contact a designated Data Controller for clarification.

- The processor must ensure that people processing the data are subject to a duty of confidence
- The processor must take appropriate measures to ensure the security of processing
- The processor must only engage a sub-processor with the prior consent of the data controller and a written contract
- The processor must assist the data controller in providing subject access and allowing data subjects to exercise their rights under the UK GDPR
- The processor must assist the data controller in meeting its UK GDPR obligations in relation to the security of processing, the notification of personal data breaches and data protection impact assessments
- The processor must delete or return all personal data to the controller as requested at the end of the contract; and
- The processor must submit to audits and inspections, provide the controller with whatever information it needs to ensure that they are both meeting their Article 28 obligations, and tell the controller immediately if it is asked to do something infringing the UK GDPR
- The contract must state that nothing within the contract relieves the processor of its own direct responsibilities and liabilities under the GDPR; and reflect any indemnity that has been agreed.
